

Pembrokeshire Agricultural Society (PAS)

Terms & Conditions 2026

1. Acceptance of Terms & Conditions of Entry

1. The services provided by the Pembrokeshire Agricultural Society Ltd ("PAS") are subject to the following Terms and Conditions ("T&Cs"). All visitors entering PAS property agree to be bound by these Regulations. PAS may update the T&Cs at any time without prior notice.
2. By entering PAS property, you agree to comply with all notices and instructions issued by management and staff, taking reasonable care for your own safety and that of others affected by your actions.
3. PAS reserves the right to refuse admission or remove any person(s) who, in its opinion, may pose a risk to others or property within the Showground.
4. Do not enter the premises if you do not agree with these T&Cs.

2. General Conditions

1. PAS may refuse admission or expel, without notice, anyone behaving unruly or likely to cause offence to others.
2. PAS accepts no responsibility for loss or damage to persons or property.
3. Visitors must comply with all PAS staff instructions at all times.
4. Alcohol, glass bottles, and glass items must NOT be brought onto the Showground.
5. Visitors may be searched upon entry. Weapons, fireworks, smoke bombs, or dangerous objects are strictly prohibited.
6. Alcohol consumption is allowed only in authorised areas and in line with the Licensing Act 2003. Intoxicated persons may be removed without refund.
7. Unnecessary noise or disruptive behaviour is not permitted.
8. In accordance with the Health Act 2006, smoking is prohibited in all buildings, marquees, and areas marked with no-smoking signs.
9. Picnics are allowed only in designated PAS picnic areas.
10. Only PAS-authorised persons may sell or offer items for sale within Showground boundaries.

11. All visitors must hold a valid admission ticket or wristband and present it for inspection upon request.
12. Children under 16 must be accompanied and supervised by an adult aged 21+.
13. Photography and videography may take place. By entering, you consent to PAS using such images for promotional purposes.
14. Offensive clothing is not permitted.
15. PAS is not liable for any indirect or consequential loss unless caused directly by negligence of PAS employees.
16. PAS does not accept responsibility for supervising individuals under 18.
17. Due to uneven terrain, spectators enter at their own risk and should wear suitable footwear.
18. Demonstrations or shows may be altered without notice for animal welfare or safety reasons.

3. Cancellation or Abandonment of the Event

PAS is not liable for any loss or damage arising from abandonment, cancellation, or postponement of the Show.

4. Data Protection

PAS follows best practices under the Data Protection Act (1998). Personal data is retained for PAS use only and is not shared with third parties.

5. Credit Card Transactions

All credit card transactions are handled via a secure encrypted server. No personal or payment information is shared with third parties.

7. Disclaimer of Liability

1. PAS reserves the right to refuse admission or revoke permission to remain on the Showground at any time.
2. Except for death or personal injury caused by PAS negligence, PAS accepts no liability for any accident, loss, injury, or illness to persons, livestock, property, or vehicles.

8. Badges, Tickets & Wristbands

1. All visitors must retain their valid admission ticket or wristband throughout their visit.
2. Tickets and wristbands are non-transferable, non-refundable, and remain PAS property.
3. Use of PAS-issued entry passes implies agreement to these T&Cs.
4. Lost or damaged passes will not be replaced.
5. Tickets are non-refundable and unused tickets cannot be reimbursed.
6. Tickets sent by Recorded Delivery become the purchaser's responsibility once posted.
7. Tickets collected on-site require proof of purchase and ID.
8. Promotions and discounts may be altered or withdrawn without notice.

9. Disabled Ticketing Policy

PAS may allow a disabled visitor to be accompanied by one carer free of charge. The disabled visitor must pay the applicable admission fee.

10. E-Ticket Promotions — T&Cs

1. Online promotional offers may be changed or withdrawn without notice.
2. Each ticket grants entry on any one day of the Pembrokeshire County Show.
3. Tickets will be scanned on entry and may be shown on paper or mobile device.
4. Not valid with any other offers.
5. Tickets are non-refundable, non-transferable, and not redeemable for cash.
6. Photocopies are not accepted.

7. PAS reserves the right to refuse entry without explanation.
8. Customers must ensure PAS holds correct contact information.

11. Terms & Conditions for County Show (2026)

1. Date & Location: The Show will be held on 19th & 20th August 2026 at the County Showground, Withybush, Haverfordwest, Pembrokeshire, SA62 4BW.
2. Cancellation of Classes/Entries: PAS may cancel or amalgamate classes. Exhibitors may be offered alternative classes or refunds.
3. Stewards: Stewards handling competing animals must not wear rosettes or badges when entering the ring.
4. Dress Code: Exhibitors/handlers must wear appropriate show attire.
5. Public Liability: All exhibitors must hold valid public liability/third-party insurance.
6. Health & Safety: All attendees must follow organiser instructions. Animals must be show-trained and equipment must be safe.
7. Animal Welfare: PAS follows the Animal Welfare Act 2006. Welfare and disease prevention measures must be followed.
8. GDPR & Data Protection: PAS complies with GDPR and Data Protection Act 1998. The Privacy Policy is available on the PAS website.
