

GENERAL REGULATIONS

1. The Show

- a. The Stokesley Show is run by Stokesley Show Limited, a company registered in England, numbered 08343391, with its registered office at 1 Mount Pleasant Way, Stokesley, TS9 5NZ.

2. Date of Show.

- a. The Stokesley Show will be held annually at Stokesley on dates advertised via its website, www.Stokesleyshow.Co.uk.

3. Date when entries received.

- a. All Entries must be made online via Showing Scene or in writing to The Secretary, Stokesley Show Limited, Oak Tree Cottage, Newsham, Thirsk, YO7 4DH on or before the current year's closing date as shown on the Show's website. Entries sent by post or made online must be accompanied by a remittance where any entrance money is payable. Blank entry forms may be obtained from the the website or the Show Secretary. NO Entries will be accepted after that date excepting Dogs, which are accepted on the field on Show Day.

4. Admission to the Field.

- a. The public will be admitted into the Show Ground at 8.30a.m. Current ticket prices are shown on the Show's Website.

5. Disabled

- a. Stokesley Show Ltd., does not wish to discriminate against visitors with disabilities, so the full admission rate will be charged. However, if a visitor has a full-time carer or attendant, a free ticket is available for them at the time of purchasing a standard price visitor ticket. This concession is only available by applying in advance, with supporting documentation to: The Secretary, Stokesley Show Ltd., Oak Tree Cottage, Newsham, thirsk YO7 4DH.

6. Power to refuse entries.

- a. Stokesley Show Limited or its agents may refuse any Entry at their discretion without giving any reason.

7. Judging in case of animals entered in more than one class.

- a. When any animal is entered in more than one Class the Society will not undertake that the two classes shall be judged at different times, nor shall the judging in one Ring be delayed to suit the convenience of Exhibitors having animals entered in more than one Class.

8. Bona fide possession.

- a. All animals must be bona fide the property of the Exhibitor at the time of Entry.

10. Exhibitor's Instructions.

- a. Every Exhibitor shall produce a passport, if so required by Show officials, to prove the age of any exhibit made by him, and shall answer all such questions as may be put to him by the official respecting his exhibit.

11. Measurements.

- a. All animals entered in Classes with conditions as to height must provide, if asked, a joint measurement certificate for each animal before prize money will be paid.

12. Conditions as to award of prizes.

- a. When any conditions attach to the winning of a premium, the prize shall not be paid until such condition has been fulfilled.

13. Tenant Farmer.

- a. When the term "Tenant Farmer" is used, it means a person who derives the principal part of his income from farming land.

14. Time for admission for exhibits.

- a. All Exhibits will be admitted to the Show Ground between 6 and 9 a.m.

15. Judges' numbers.

- a. All Animals brought to the Show Ground for exhibition must have a Judges' number attached. These numbers will be sent by post or electronic means. Corresponding numbers will be attached to each stall or pen prepared on the Show Ground for each animal or pen of animals, and on no account shall any person be allowed to remove any animals from the stalls or pens so assigned to them until the close of the Show, except when taken before the Judges.

16. Foals.

- a. All foals entered for the Stokesley Show Ltd must be haltered and led into the ring when under inspection of the Judges.

17. Poultry, etc.

- a. The Show of Poultry, Pigeons, Rabbits and Cavies will be arranged in suitable pens in Tents erected for the purpose. Exhibitors must provide own water containers. No person will be allowed to remove any bird except in the presence of the Stewards. Exhibitors of Ferrets to provide their own pens.

18. Non-liability of Stokesley Show Ltd.

- a. Stokesley Show Ltd will not be responsible for any losses, mistakes, or accidents of any description that may occur to any entry, and entries will be received subject to this condition.

19. Epidemic disorder.

- a. Any Exhibitor bringing any animal into the Show Ground diseased with any epidemic disorder shall, on proof thereof, forfeit £200 to the Secretary for the use of the Stokesley Show Ltd; and any
- b. Exhibitor giving a false or incorrect certificate shall forfeit every unpaid prize and all entrance money.

21. Objection.

- a. Any person wishing to lodge an objection to the award of any prize, must do so in writing to the Secretary within one hour after the Class is judged, or within one hour of the opening of the tent in which the Exhibit is staged, and deposit with them the sum of £25, and if on investigation by the Stokesley Show Ltd the objection is not sustained to their satisfaction, the deposit money shall, at the discretion of the Stokesley Show Ltd, be forfeited to the funds of the Stokesley Show.

22. Withholding of award.

- a. The Judges shall not award any prize unless the Exhibits are deemed worthy.

23. Disqualification.

- a. In all cases of disqualification, the animal or other exhibits placed next in merit shall succeed to the prize.

24. Infringement of rules to debar from exhibiting.

- a. If any exhibitor shall, in the opinion of the Stokesley Show Ltd, infringe these Rules and Regulations they may be disqualified by the Stokesley Show Ltd from competing at the Show for the next succeeding three years, and be liable to forfeit all claims to any Prizes which may have been awarded to him, or he may otherwise be dealt with as Stokesley Show Ltd in its absolute discretion may think fit. Stokesley Show Ltd shall be indemnified against any legal proceedings arising from the disqualification.

25. Compensation

- a. Stokesley Show Ltd will not be in any way responsible for any claim for compensation or otherwise in regard to the holding, or for anything arising out of, or connected with, their Shows.

26. Responsibility for Accidents.

- a. The Stokesley Show Ltd will not be responsible for any accident that may occur from the Machinery belonging to any Exhibitor; and it is a condition of Entry that each Exhibitor shall hold the Stokesley Show Ltd blameless and indemnify it against any legal proceedings arising from any accident caused by an exhibitor's machinery.

27. Parade.

- a. PARADE of ALL PRIZE-WINNERS in the Cattle Section 3.00 p.m, followed by Horse Section in THE MAIN RING. Winners to be ready, and same must parade or Prize Money will be withheld.

28. Disputes.

- a. The decision of the Stokesley Show Ltd shall be final and binding in all questions or disputes of any kind whatsoever arising out of or in connection with this Stokesley Show. All persons entering exhibits for this Show shall by such act be deemed to have agreed with the Stokesley Show Ltd to refer such questions or disputes to that Stokesley Show Ltd, and it is on this distinct understanding that entries are accepted.

29. Tradestands

- a. To be on the field by 8am. (This rule will be strictly applied)

30. Vehicles

- a. All essential pass holding vehicles to be on the show field by 8.30am and exhibits to be in the relevant marquee. No movement of vehicles after 8.30am.

31. Cancellation of Classes

- a. The show reserves the right to retain 20% of entry fees, in the event of the class(es) being cancelled, for administration charges. Applications for refunds to be received in writing within 21days of show date.

32. Wearing of Protective Head Gear

- a. When competing in the Ring, the practice or collecting areas, all Riders must wear protective headgear, according to the current British standards as listed below: All PAS 015; VG1; (BS)EN1384 2017; ASTM F1163 04a onwards; SNELL E2001; SNELL E2016; AS/NZS 3838 2003 onwards;

33. Official Photographs

- a. Our official photographers will be taking photographs, we reserve the right to use said photographs in Stokesley Show publicity and also on the photographers website.

34. Mock Auctions.

- a. Mock Auctions WILL NOT BE ALLOWED on the Show Ground. By Order of Stokesley Show Ltd.

35. Health And Safety Policy

- a. Available to be inspected in the Secretary's office on show day, or beforehand by contacting the show Secretary.
