

# Leek & District Agricultural Show Terms & Conditions

## 1. ACCEPTANCE OF TERMS

Leek & District Agricultural Show provides a collection of online resources, including classified ads, forums, catalogues, and various email services available on or through Leek & District Agricultural Show (referred to hereafter as “the Service”) subject to the following Terms of Use (“TOU”). By using the Service in any way, you are agreeing to comply with the TOU. In addition, when using particular Leek & District Agricultural Show services, you agree to abide by any applicable posted guidelines for all Leek & District Agricultural Show services, which may change from time to time. Should you object to any term or condition of the TOU, any guidelines, or any subsequent modifications thereto or become dissatisfied with the Service in any way, your only recourse is to immediately discontinue use of the Service.

## 2. MODIFICATIONS TO THIS AGREEMENT

We reserve the right, at our sole discretion, to change, modify or otherwise alter these terms and conditions at any time. Such modifications shall become effective immediately upon the posting thereof. You must review this agreement on a regular basis to keep yourself apprised of any changes.

## 3. ELIGIBILITY FOR USE

Leek & District Agricultural Show reserves some parts of the Service exclusively for professional purchasers, sellers, collectors and resellers of items and accessories who are acceptable to Leek & District Agricultural Show in its sole discretion. Although Leek & District Agricultural Show attempts to limit the use of these parts of the Service to such purchasers, sellers, collectors and resellers of items and accessories, nothing herein shall create any right of action against Leek & District Agricultural Show for failing to adequately screen potential users or prevent the use of Leek & District Agricultural Show or the Service by users who are not professional purchasers, sellers, collectors and resellers of items or accessories.

## 4. CONTENT

When you post User Content to the Service, you authorize and direct us to make such copies thereof as we deem necessary in order to facilitate the posting and storage of the Content on the Service. The identity of the material on Leek & District Agricultural Show that you claim is infringing, in sufficient detail so that we may locate it on the website;

A statement by you that you have a good faith belief that the disputed use is not authorized by the copyright owner, its agent, or the law;

Your address, telephone number, and email address;

A statement by you declaring under penalty of perjury that (i) the above information in your Notice is accurate, and (ii) that you are the owner of the copyright interest involved or that you are authorized to act on behalf of that owner; and

Your physical or electronic signature.

## 7. PRIVACY AND INFORMATION DISCLOSURE

Leek & District Agricultural Show may, in its sole discretion, preserve or disclose your Content, as well as your information, such as email addresses, IP addresses, timestamps, and other user information. We report to you that contact details of exhibitors will be made available to our catalogue producers. Your contact details personal information is further governed by Leek & District Agricultural Show’s Privacy Policy.

## 8. CONDUCT

You agree not to post, email, or otherwise make available Content:

that is unlawful, harmful, threatening, abusive, harassing, defamatory, libelous, invasive of another’s privacy, or is harmful to minors in any way;

that is pornographic or depicts a human being engaged in sexual activities or exposing sexual organs unfitting for the Service;

that harasses, degrades, intimidates or is hateful toward an individual or group of individuals on the basis of religion, gender, sexual orientation, race, ethnicity, age, or disability;

that suggests a discriminatory preference based on race, colour, national origin, religion, sex, familial status or handicap (or violates any state or local law prohibiting discrimination on the basis of these or other characteristics);

that violates federal, state, or local equal employment opportunity laws, including but not limited to, stating in any advertisement for employment a preference or requirement based on race, colour, religion, sex, national origin, age, or disability;

with respect to employers that employ four or more employees, that violates the anti-discrimination provision of the Immigration and Nationality Act, including requiring U.S. citizenship or lawful permanent

residency (green card status) as a condition for employment, unless otherwise required in order to comply with law, regulation, executive order, or federal, state, or local government contract;

that includes personal or identifying information about another person without that person's explicit consent;

that constitutes or contains any form of advertising or solicitation if: posted in areas of Leek & District Agricultural Show which are not designated for such purposes;

or emailed to Leek & District Agricultural Show users who have not indicated in writing that it is ok to contact them about other services, products or commercial interests. that includes links to commercial services or web sites, except as specifically permitted;

that advertises any illegal service or the sale of any items the sale of which is prohibited or restricted by any applicable law;

that contains software viruses or any other computer code, files or programs designed to interrupt, destroy or limit the functionality of any computer software or hardware or telecommunications equipment;

that disrupts the normal flow of dialogue with an excessive amount of Content (flooding attack) to the Service, or that otherwise negatively affects other users' ability to use the Service;

or that employs misleading email addresses, or forged headers or otherwise manipulated identifiers in order to disguise the origin of Content transmitted through the Service.

Additionally, you agree not to:

contact anyone who has asked not to be contacted;

"stalk" or otherwise harass anyone;

collect personal data about other users for commercial or unlawful purposes;

use automated means, including spiders, robots, crawlers, data mining tools, or the like to download data from the Service – unless expressly permitted by Leek & District Agricultural Show;

post irrelevant Content, repeatedly post the same or similar Content or otherwise impose an unreasonable or disproportionately large load on our infrastructure;

post the same item or service in more than one classified category or forum;

attempt to gain unauthorized access to Leek & District Agricultural Show's computer systems or engage in any activity that disrupts, diminishes the quality of, interferes with the performance of, or impairs the functionality of, the Service or Leek & District Agricultural Show;

or use any form of automated device or computer program that enables the submission of Content on Leek & District Agricultural Show without such Content being manually entered by the author thereof (an "automated posting device"), including without limitation, the use of any such automated posting device to submit Content in bulk, or for automatic submission of Content at regular intervals.

## 9. POSTING AGENTS

A "Posting Agent" is a third-party agent, service, or intermediary that offers to post Content to the Service on behalf of others. To moderate demands on Leek & District Agricultural Show's resources, you may not use a Posting Agent to post Content to the Service without express permission or license from Leek & District Agricultural Show. Such violations may subject the sender and his or her agents to civil and criminal penalties.

## 11. PAID POSTINGS

We may charge a fee to post Content in some areas of the Service. The fee is an access fee permitting Content to be posted in a designated area. Each party posting Content to the Service is responsible for said Content and compliance with the TOU. All fees paid will be non-refundable in the event that Content is removed from the Service for violating the TOU. Fees collected for specific services, such as subscription services and advertising, are non-refundable unless otherwise stated in writing for a specific promotional program.

## 12. LIMITATIONS ON SERVICE

You acknowledge that Leek & District Agricultural Show may establish limits concerning use of the Service, including the maximum number of days that Content will be retained by the Service, the maximum number and size of postings, email messages, or other Content that may be transmitted or stored by the Service, and the frequency with which you may access the Service. You agree that Leek & District Agricultural Show has no responsibility or liability for the deletion or failure to store any Content maintained or transmitted by the Service. You acknowledge that Leek & District Agricultural Show reserves the right at any time to modify or discontinue the Service (or any part thereof) with or without notice, and that Leek & District Agricultural Show shall not be liable to you or to any third party for any modification, suspension or discontinuance of the Service.

## 13. ACCESS TO THE SERVICE

Leek & District Agricultural Show grants you a limited, revocable, nonexclusive license to access the Service for your own personal use. This license does not include: (a) access to the Service by Posting

Agents; or (b) any collection, aggregation, copying, duplication, display or derivative use of the Service nor any use of data mining, robots, spiders, or similar data gathering and extraction tools for any purpose unless expressly permitted by Leek & District Agricultural Show. A limited exception to (b) is provided to general purpose internet search engines and non-commercial public archives that use such tools to gather information for the sole purpose of displaying hyperlinks to the Service, provided they each do so from a stable IP address or range of IP addresses using an easily identifiable agent and comply with our robots.txt file. "General purpose internet search engine" does not include a website or search engine or other service that specializes in classified listings or in any subset of classified listings such as decorative goods or furniture, or which is in the business of providing classified ad listing services.

modification, creation of derivative works from or redistribution of the site or the collective work, and/or copying or reproducing the sites or any portion thereof to any other server or location for further reproduction or redistribution is prohibited without the express written consent of Leek & District Agricultural Show. You further agree not to reproduce, duplicate or copy Content from the Service without the express written consent of Leek & District Agricultural Show, and agree to abide by any and all copyright notices displayed on the Service. You may not decompile or disassemble, reverse engineer or otherwise attempt to discover any source code contained in the Service. Without limiting the foregoing, you agree not to reproduce, duplicate, copy, sell, resell or exploit for any commercial purposes, any aspect of the Service. #### 19. GENERAL INFORMATION

The TOU, and any additional terms to which you agree when using particular elements of the Service, constitutes the entire agreement between you and Leek & District Agricultural Show and governs your use of the Service, superseding any prior agreement between you and Leek & District Agricultural Show. The failure of Leek & District Agricultural Show to exercise or enforce any right or provision of the TOU shall not constitute a waiver of such right or provision. If any provision of the TOU is found by a court of competent jurisdiction to be invalid, the parties nevertheless agree that the court should endeavor to give effect to the parties' intentions as reflected in the provision, and the other provisions of the TOU remain in full force and effect. You agree that regardless of any statute or law to the contrary, any claim or cause of action arising out of or related to use of the Service or the TOU must be filed within one (1) year after such claim or cause of action arose or be forever barred.

#### 20. VIOLATION OF TERMS AND LIQUIDATED DAMAGES

Our failure to act with respect to a breach by you or others does not waive our right to act with respect to subsequent or similar breaches.

You understand and agree that, because damages are often difficult to quantify, if it becomes necessary for Leek & District Agricultural Show to pursue legal action to enforce the TOU, you will be liable to pay Leek & District Agricultural Show the following amounts as liquidated damages, which you accept as reasonable estimates of Leek & District Agricultural Show's damages for the specified breaches of the TOU:

If you post a message that (i) impersonates any person or entity; (ii) falsely states or otherwise misrepresents your affiliation with a person or entity; or (iii) that includes personal or identifying information about another person without that person's explicit consent, you agree to pay Leek & District Agricultural Show one thousand dollars pounds (1000) for each such message. This provision does not apply to messages that are lawful non-deceptive parodies of public figures.

If Leek & District Agricultural Show establishes limits on the frequency with which you may access the Service, or terminates your access to or use of the Service, you agree to pay Leek & District Agricultural Show one hundred pounds (£100) for each message posted in excess of such limits or for each day on which you access Leek & District Agricultural Show in excess of such limits, whichever is higher.

If you send unsolicited email advertisements to Leek & District Agricultural Show email addresses or through Leek & District Agricultural Show computer systems, you agree to pay Leek & District Agricultural Show twenty five pounds (£25) for each such email.

If you post Content in violation of the TOU, other than as described above, you agree to pay Leek & District Agricultural Show one hundred pounds (£100) for each item of Content posted. In its sole discretion, Leek & District Agricultural Show may elect to issue a warning before assessing damages.
