TERMS AND CONDITIONS

1. The Show is open to all.
2. An exhibitor may have more than one entry in any Class unless otherwise stated in the Schedule.
3. No animal may be entered for or compete in more than one of the Ordinary Classes unless otherwise stated.
4. Only stock entered in the Catalogue will be allowed to compete in any of the Classes unless extra special circumstances are deemed to exist.
5. All entries must be made to the Show Team on the appropriate entry schedule no later than the closing date stated in the schedule.

NO ENTRIES WILL BE ACCEPTED UNLESS ACCOMPANIED BY THE APPROPRIATE FEES AT THE STANDARD RATE PREVAILING AT THE DATE OF RECEIPT OF ENTRY.

There can be no changes made to entries after the closing date.

No entries will be accepted on the day unless stated in the schedule.

6. All Exhibitors must pay due regard to Bio Security requirements and the Health and Safety of the public attending the event.
7. All Exhibitors must be covered by their own public liability insurance and all accidents reported to the section convenor.
8. Entry Fees are as per schedule for that section.

First Aid Levy: £1 per Exhibitor/Handler in livestock classes.

9. The pedigree and ages of all Pedigreed Cattle, Horses and Ponies and Goats must be included with the entry schedule. Please insert the class number and the ear tag number of all cattle entries.
10. Once all the entries are made, the show team will return an entry schedule to the exhibitor with numbers for each exhibit. There will be no transferring of classes on the day of the show. Exhibitors will be issued with the allocated number of passes for stock attendants and vehicles to allow access to the Showfield, and final instructions.

11. Prize Money will be paid by Bank Transfer no later than 1st October. In the event of bank details not being provided to the Association, prize money will be retained as a donation.

IF EXHIBITORS HAVE ENTERED MORE THAN ONE CLASS AND BOTH ARE BEING JUDGED AT THE SAME TIME A DECISION MUST BE MADE TO WHICH CLASS IS BEING ENTERED. CLASSES WILL NOT BE DELAYED FOR EXHIBITORS TO ENTER BOTH. IT MUST BE CLEARLY STATED ON ENTRY FORM IF ANIMAL IS BEING SHOWN IN MORE THAN ONE CLASS.

ALL ENTRIES SHOULD BE REVISED CAREFULLY, MAKING SURE ALL PARTICULARS ARE CORRECT IN ACCORDANCE WITH THE SCHEDULE BEFORE SENDING.

MISCELLANEOUS INFORMATION

Admission to the showground

Entry to the showground is permitted only with a valid Badge and/or Admission Ticket. Anyone unable to present a ticket must pay the full admission fee for that day, which is non-refundable. During public opening hours, re-entry is allowed with a wristband, which must be obtained from gate staff upon exiting.

Vehicle Access to the Showground

Vehicles will not be admitted to the Showground on show days without an 'Admit to Showfield Pass'. Passes will be issued based on the entries received. If an additional pass is required, please contact the office to discuss your needs.

Admission of Members

TDAА membership is available at an annual fee set by the show committee each year. Each fully paid member will receive one badge and a ticket for each day of the show. Please note that both the member's badge and the corresponding ticket MUST be presented together to gain entry to the show.

PLEASE NOTE:

- Subject to the Memorandum and Articles of Association the annual membership fee is due by 30th June each year.
- Exhibitor membership fee must be paid along with entries.

Admission of Exhibitors

Admission tickets will be sent to Exhibitors along with their competition numbers. Please note that Stock Exhibitor wristbands do not grant admission into the Show. They only indicate authorisation to access the stock lines.

Admission of the Public

The Showground will be open for admission of the public during the following hours:

Sunday from 7.00am – 8.00pm

Monday from 7.00am – 6.00pm

LIVESTOCK

1. All cattle, sheep, goats, collie dogs, fur and feather shown must have been the absolute property of the Exhibitor for one month prior to the Show and the owner must give satisfactory evidence of the age and other requisites of the animal to be allowed to compete.
2. Livestock entering the Showfield for exhibition on the Monday should not arrive before 7.00pm on the Sunday unless prior permission is sought from the Show Team.
3. All animals entered for exhibition must remain in the Showfield until 3.00pm on the afternoon of the Show.
4. Animals moving to shows for exhibition for the first time will not have to be kept separate prior to moving to the show irrespective of whether any other livestock have been moved onto those premises in the 13-day period immediately before moving. If attending only one show within any one 13-day period, the animal will not require to be held separate on return from the show nor will the return home trigger a 13-day standstill for any other animal on the home farm. Also, animals may move from show to show or may return to their usual premise of residence without triggering a 13-day standstill provided they are kept in separate facilities under an authorised separation agreement with SGRD.
5. The Transport of Animals (Cleansing and Disinfection) (Scotland) Regulations 2005 applies to vehicles taking animals to and from a show/exhibition.

HORSES & PONIES

1. All equines in Scotland must have an equine passport and be microchipped in accordance with the Equine Animal (Identification) (Scotland) Regulations 2019. Passports must accompany the animal and may be inspected by authorised officials.

2. It is strongly advised that all equines wishing to compete are properly vaccinated against Equine Influenza. Please consult with your own veterinary practise regarding correct vaccination process. This rule is subject to change.
3. Horse or pony exhibitors cannot show any animal that has been bred, leased, sold or on loan from the Judge.
4. If the horse or pony exhibitor does not own the animal then full details of the owner's name and address must be provided with the entry.
5. HATS
Correctly secured Skull Caps/Riding Hats Nos. PAS015 2011, VG1 01.040 (2014-12), (BS) EN1384 2023, ASTM F1163 2015 & 2023, SNELL E2016 & E2021, AS/NZS 3838 2006 onwards, MUST be worn by riders at all times when mounted. Hats should have a plain cover either Black, Navy Blue, Brown, Grey or Green.

CATTLE

1. All cattle for exhibition must comply with current Scottish Government Rural Directorate regulations.
2. Cows of all Beef Breeds, other than the British Blue breed, whether or not having at some time been subject to ovum transfer or a flushing programme, must have given birth to a live or full-term calf on or after 1st August 2025 and before the day of the Show.
3. Beef Shorthorn and Aberdeen Angus two-year-old heifers must be in calf or have had a calf when exhibited.
4. Pure-bred bullocks and pure unregistered heifers may compete in the Commercial Cattle Section.
5. All cattle must be led in the Judging Rings.
6. Cattle must be ear tagged in accordance with Scottish Government Rural Directorate guidance.

7. All Carcase cattle must be Farm Assured.
8. **All movements 'on' and 'off' showgrounds must be notified to ScotEID. When an animal moves to and from a showground, you must:**
 - report the 'off' movement from your holding
 - report the 'on' movement back to your holding

A MEMBER OF THE SHOW COMMITTEE WILL UPDATE YOUR ON AND OFF MOVEMENT. You must provide the completed Ear Tag Declaration Form for the committee member to complete. Ear Tag Declaration form will be sent to you with exhibitor numbers. Please ensure this is done prior to the commencement of judging. Turriff Show labels with the **Showfield CPH number 66/083/8020**, will be issued at the Show on receipt of the completed Ear Tag Declaration.

For each animal taken to the Showground you must have the following documents:

- a new single page passport (CPP52)

9. In the event of new Animal Health Legislation being enacted between the date of preparation of this Schedule and the date of the Show Exhibitors will be expected to abide by any new conditions of that legislation.

Notifiable Disease

Any animal which shows signs suggestive of a notifiable disease, e.g. FMD, BSE must be reported to the Society's Official Duty Veterinary Surgeons or Official Convenors. All requests and instructions by the Official Duty Veterinary Surgeons, Convenors concerning the suspected animal(s) must be complied with.

Bovine Tuberculosis

Any exhibitor bringing cattle to the Show from outwith Scotland must in the previous 30 days from the Show have obtained a negative TB result on all the cattle being brought to the Show.

Bovine Viral Diarrhoea

All cattle (including calves) coming to the Show must come from a Scottish holding with 'negative' herd status for BVD, from a herd that is fully accredited free of BVD or they must all be individually tested free of virus (antigen) whether or not they have been vaccinated, in accordance with CHecs rules (www.checs.co.uk).

SHEEP & GOATS

1. Sheep and goats including lambs must be individually identified in accordance with current Scottish Government Rural Directorate guidance. Spot checks that reveal any sheep or goats not complying may be spray-marked after judging. The Area Office may issue a warning letter and on-farm checks may follow. <https://www.gov.scot/publications/livestock-identification-and-traceability-guidance/pages/sheep-and-goats/>
2. All Butchers Lambs must be Farm Assured.
3. The Exhibitor must complete a separate Movement Document for the journey to and from the showground. This should include your full CPH number and the **Showfield CPH number 66/083/8020**. The need to individually record tag numbers on the Movement Document has been removed. Do not surrender the document to show organisers.
4. The Movement Document should be available for inspection by Scottish Government Rural Directorate/Local Authority staff upon request. If you are unsure of the action required, please contact your local area office or SAMU (Tel: 0300 244 5888).
5. Within 3 days of returning home, the exhibitor/keeper must notify the Scottish Animal Movement Unit (SAMU) of the move by e-mail, fax or post.

6. Maedi Visna/Caprine Arthritis Encephalitis Accreditation Scheme. Exhibitors must ensure correct certificate of status is taken along to the show (current valid SAC Scheme form or Health Status Report, signed, dated with destination and ear numbers of animals completed in full by exhibitor). Paperwork must be ready for inspection by sheep/goat convenors on approach to the sheep/goat penning areas. Accredited animals will not be permitted to unload without it.

7. Separate unloading and re-loading points for MV/CAE Accredited and Non-Accredited stock will be available in the showfield. MV/CAE Accredited and Non-Accredited stock must not come into contact at any time during the Show.
8. Attendants on sheep are required to wear white coats while leading animals in the judging rings.

RABBITS, CAVIES & PIGEONS

1. Animals must not be boxed until 4.00pm unless authorised by convenor.
2. RABBITS ONLY - It is planned to hold classes, bearing in mind that any development of VHD could result in Cancellation. The British Rabbit Council will advise on Correct Procedure.
3. PIGEONS ONLY – No person is allowed to leave the Marquee when boxing up, until all exhibitors have basketed their pigeons. All **RACING** pigeons entered **MUST** have been vaccinated against Paramyxovirus 1.

PARADE

1. All 1st–4th prize winners in the Horse and Pony, Cattle, Goat and Collie Dog Sections should have their animals ready to parade at the appointed time. Horses, Ponies, Donkeys and Goats should be ready to parade at 2.15pm on the Sunday and Clydesdale Horses, Cattle and Collie Dogs at 2.00pm on the Monday.

Failure to do so may result in prize money and prizes being forfeited. Prizes, rosettes, and numbers to be displayed prominently on the near side (left hand side looking from the rear) of the animal.

JUDGING

1. Horses and Ponies (except Clydesdale Horses), Goats, Rabbits, Cavies and Pigeons are judged on the Sunday of the show.
2. Clydesdale Horses, Cattle, Sheep and Eggs are judged on the Monday of the show.
3. All animals must be penned in the Show yard by 7.30am for judging to commence promptly as per Judging Timetable.
4. Judges are empowered to award prizes even though there should only be one entry.
5. Where more than one Judge is used to award a Special Prize or Championship, each Judge will decide which exhibits, having already come before them, shall be brought forward.

6. If the Overall Judge has an interest in any of the Section Champions, they will judge the remaining animals, and another Judge will be appointed on the day to slot the animal(s) in question in the overall line up.
7. Industrial Section Judging shall commence at 10.00 a.m. on the Sunday of the Show.
8. Horticultural Judging shall commence at 10.15am on the Sunday of the Show.
9. Vintage Vehicle Judging will commence at 11am, on the Sunday of the show. Please note the judge may not make himself known to the exhibitors.

INDUSTRIAL SECTION

1. The Industrial Competition is open to all.
2. There are no class entry fees for the Industrial Competition. Entry into this Competition does not allow admission into the Show.
3. Exhibits must be the bona fide work of the Exhibitor in whose name the entry is made and must have been worked since 5TH AUGUST 2025. The only exception is for any individual item previously entered in the Co-operative classes in 2025 (Sections 13, 15 & 16).
4. Exhibitors may enter only one exhibit in any class, except in the Shepherd's Crooks & Walking Sticks section, where two entries per class are allowed.
5. All Exhibits must be delivered to the Industrial Committee within the Industrial Marquee in the Showfield from 7.00 a.m. until 9.30 a.m. on SUNDAY 2nd AUGUST 2026. Where Exhibitors find it impossible to deliver Exhibits personally, such Exhibits will be carefully attended to if forwarded to the Association to be in their hands not later than 5 p.m. on SATURDAY 1st AUGUST 2026.
6. While every care will be taken of Exhibits, such shall be entirely at the Exhibitor's own risk. The Association shall not be liable for any loss or damage Exhibits may sustain at the Show or in transit.
7. Exhibits shall be removed between 5.00 p.m. and 5.45 p.m. on MONDAY 3rd AUGUST 2026. WE WILL NOT ALLOW VEHICLE ACCESS FOR COLLECTION OF EXHIBITS BEFORE 5PM ON MONDAY 3RD AUGUST 2026 IN THE INTEREST OF HEALTH AND SAFETY.
8. Any food items which have not been collected will be disposed of at 5.45pm.

9. In Points Competition a First Prize shall be awarded 4 Points; a Second Prize, 3 Points; a Third Prize, 2 Points; and a Fourth Prize, 1 Point.
10. Judges have the right to turn out contents of Jars, Bottles or other Containers, and to cut or break cakes, etc.
11. In the interest of food hygiene, it is recommended that all food items exposed to the open air be discarded after the show in waste bags provided by the Association.
12. FOR SECTIONS 13, 15 & 16
IN THE EVENT THAT MORE THAN ONE ITEM RECEIVES 10 POINTS, THE JUDGES WILL SELECT THE WINNER OF THE TROPHY FOR THE OUTSTANDING EXHIBITS AND THIS WILL BE INDICATED ON THE SCORE CARD WITH A GOLD STAR.
13. No Challenge of Entries, Classification of Exhibits, Awards of the Judges, or any other procedure shall be competent after 1 p.m. of the second day of the Show, and all Challenges, must be lodged with the Show team in writing before that time along with £25 which shall be forfeited to the Association should it be the opinion of the Committee of Management that the protest was raised on unreasonable grounds. The Committee shall have the power to settle all disputed questions connected with the Exhibition, and against their decision there shall be no appeal.
14. Fifth and Sixth prize cards may be awarded but with no points or money value.

HORTICULTURE SECTION

1. The Horticultural Competition is open to all, with the exception of those classes specified within the schedule.
2. There are no class entry fees for the Horticultural Competition. Entry into this Competition does not allow admission into the Show.
3. Flower vases are provided free of charge by the Association. Vases must not be removed from the Marquee.
4. Exhibitors are not permitted to enter exhibits which have not been in their possession for 2 months prior to the date of the Show. We cannot accept entries from two different individuals from the same garden in the same class.

5. Exhibits **MUST** be presented within the Horticultural Section Marquee in the Show field between 7pm on SATURDAY 1st and no later than 9.45am on SUNDAY 2nd AUGUST 2026, by which time all staging **MUST** be completed. **NO PRELIMINARY ENTRY IS NECESSARY.**
6. The arrangement of Exhibits on tables shall be wholly under control of The Horticultural Committee who are appointed by the Association.
7. While every care will be taken of Exhibits, such shall be entirely at the Exhibitors' own risk. Exhibitors will be solely responsible for delivery and removal of their own Exhibits. The Association shall not be liable for any loss or damage which Exhibits may sustain at the show or in transit.
8. Exhibits must only be removed between 5.00pm & 6.00pm on MONDAY 4th AUGUST 2025. **WE WILL NOT ALLOW VEHICLE ACCESS FOR COLLECTON OF EXHIBITS BEFORE 5.00PM ON MONDAY 4TH AUGUST 2025 IN THE INTEREST OF HEALTH AND SAFETY.**
9. An Exhibitor may show a maximum of two entries per class.
10. In Points Competition a First Prize shall be awarded 3 Points; a Second Prize, 2 Points; and a Third Prize, 1 Point.
11. No Challenge of Entries, Classification of Exhibits, Awards of the Judges, or any other procedure shall be competent after 1 p.m. of the second day of the Show, and all Challenges, must be lodged with the Show team in writing before that time along with £25 which shall be forfeited to the Association should it be the opinion of the Committee of Management that the protest was raised on unreasonable grounds. The Committee shall have the power to settle all disputed questions connected with the Exhibition, and against their decision there shall be no appeal.

CEREAL COMPETITION

1. The competition is open to members of the Turriff District Agricultural Association.
2. Only one entry per business/company name is permitted in each of the categories.
3. Crops will be assessed based on Quality and potential yield, Uniformity, Freedom from weeds and pests, Grain size & Estimated plant stand
4. Minimum Field Size 4 hectares (9.88 acres).

6. For field Location, visit <https://what3words.com> to find the precise location of the gate entrance to the relevant field. This will ensure the judge can locate the crop easily.
7. Closing Date for Entries as per schedule.

SHOW JUMPING & SPORTS EVENTS

1. All owners and riders (and where applicable parents or guardians), of horses and ponies competing in any show jumping competition in this Show shall be deemed to be subject to the rules of the British Show Jumping Association. <https://www.britishshowjumping.co.uk/>
2. Horse and Pony passports must be available for inspection by officials on request.
3. Competitors and others are recommended to make themselves acquaint with such traffic regulations as may be passed by the Magistrates. These regulations will be duly advertised and prominently signposted throughout the showground.
4. Events are timetabled according to the Sports Schedule however, the Management Committee reserve the right to alter or cancel any of the events if necessary and will not be responsible for any loss or damage caused in the field. Competitors must observe the progress of the events and be ready to enter the Showring in time for their competition. Any competitor neglecting to observe this will lose the chance of competing. Events will not be held up.
5. Competitors must abide by the decision of the Official Measurer.
6. Horses will convene in the ring at the West end of the Sports Arena and have their numbers attached.
7. There will be no allowance for practising riding either inside or outside the Showring except in the Competition. Competitors attempting such will be disqualified.

8. The overuse of whips by riders on their mounts or causing any obstruction whatsoever to the competitors will be disqualified immediately.
9. Only Judges, Stewards, their Assistants, Attending Members and Officials are allowed in the showing.
10. All competitors and animals taking part in the competitions do so at their own risk.
11. All competitors must co-operate with the organisers in compliance with Health and Safety Regulations and do all that is practicable to ensure the health, safety, and welfare of those attending. All exhibitors and attendants must ensure that they conduct themselves in a manner so that they do not put themselves or anyone else at risk.
12. The Judge's decision is final in all events.
13. Competitors in all events co-operate fully with the requirements of this Sports Schedule and in particular be prepared to enter the showing or performance area immediately when they are called.

VINTAGE & CLASSIC VEHICLES

1. ALL DRIVERS MUST HAVE A VALID DRIVING LICENCE.
2. No passengers permitted unless the vehicle has a designated passenger seat.
3. All Exhibitors must provide a valid Certificate of Motor Insurance for their vehicles or a Public Liability Insurance Certificate for any stationery engines.
4. Exhibits will only be accepted from exhibitors who have returned completed entry forms along with the completed risk assessment (only one Risk Assessment required for an entry, not per vehicle) and relevant insurance certification for each vehicle.
5. Entry to the show ground with a vintage vehicle requires an official Vintage Vehicle Show Car Park Hanging Ticket (issued in advance). One pass admits one vehicle + driver. Note that the pass does not include additional passengers in the vehicle. No access will be granted without prior entry and a valid Car Park Pass.
6. All exhibits must be on site and stationery by 10.00am on Sunday of the show.

- Engines that are running must be supervised at all times by a responsible adult and never be left unattended.
- JUDGING WILL COMMENCE AT 11am – JUDGE MAY NOT MAKE THEMSELVES KNOWN TO EXHIBITORS.

CARRIAGE DRIVING COMPETITION

- Horses and Ponies must be 4 years old or over.
- Drivers should provide brief details of experience.
- Each driver must carry a competent groom.
- Hard hats complying with the current approved standard i.e. EN1384:2023 are strongly recommended and the judge will be asked not to mark down competitors for wearing suitable head protection.
- Any carriage driver, groom or passenger, entering the competition without suitable head protection, does so at his or her own risk.
- No passengers are allowed on a vehicle or carriage without a driver.
- Harness will be inspected prior to class.
- Copy of evidence of insurance to be submitted with entry form.

TRADESTANDS

- All trade stands are booked before the commencement of the Show and sub-letting is STRICTLY PROHIBITED. Stand holders are NOT PERMITTED to trade out with the opening times of the Show.
- Stand holders are not permitted to encroach onto an adjacent Stand for any reason whatsoever.

3. All stands or covered enclosures must be constructed or lined with flame-retardant material compliant with current fire safety standards. New manufactured membranes and fabrics providing weatherproof coverings shall be of inherently flame-retardant fabric or durably flame retardant when tested to BS 5438.
4. All supporting poles, frames, guys, stakes, anchors, fastenings etc. shall be regularly tested and maintained in a safe condition. All structures shall be erected by competent persons and be erected to ensure that they shall not, as far as reasonably practicable, collapse when exposed to fire. Any rigid internal wall linings and flooring used in structures shall not be less than Class 1 surface spread of flame rating as described in BS 476: Part 7.
5. A valid fire-retardancy certificate must be available for inspection by the Fire Authority.
6. No LPG gas or liquid fuel burning appliances will be used to heat the stands or tents.
7. Any stand not operating as agreed with the Show team or found to be selling suspect goods will be removed from the Show field without recompense.
8. Additional admission tickets can be purchased online from the Turriff Show Website.
9. No Trading is allowed on the Saturday before the Show. Unless prior agreement has been made with the Show Team.
10. **No** alcohol can be sold before 10am on Sunday or Monday as per the Licensing (Scotland) Act 2005.
11. All exhibitors, stand holders and their attendants must co-operate with the organisers in compliance with Health and Safety Environmental Regulations and everything practicable must be done to ensure the health, safety and welfare of those attending. All exhibitors, stand holders and attendants must ensure they conduct themselves in a manner so that they do not put themselves or anyone else at risk.
12. In the event of any accident occurring, the stand holder must report the circumstances immediately to the Show Team or the Health and Safety Officer.
13. All flammable liquids and hazardous chemicals on site must be stored in minimum required amounts and correct storage vessels. Show Team are to be notified of all chemical types and amounts prior to show attendance. This must be detailed in trade stand Risk Assessment.
